Electricity is included, but can be used for LED lighting only! Please bring at least 1(one) 100 foot extension cord.

We ask that all vendor vehicles remain parked during the Event. Vendors who need to leave daily may park at the gate in Lotus parking lot. Please bring your own 10' X 10' tent and any necessary equipment. Arrive Early for best site options! Thank you for being flexible!
