## 2019 Vendor Rules & Regulations

1. Floyd Yoga Jam is a 4 DAY Festival with gates opening to the public at 9am on Thursday, August 29th!
2. Gates open for Vendor set-up on Wednesday, August 28th at 8am. All vehicles must be off the field and parked in designated parking areas by 8pm.
3. Vendor booths sites are 10'x10' with 2' of safety zones between booths. **Camping options vary by location**, but all options are nearby. Once the event starts we ask that you don't move your vehicle until Monday morning. If you need to leave, please park in our free day parking lot at Box Office and then come and go as you please. There are shuttles available to transport you and your restock if needed. **Note:** *Vendors in the Art Village and Healing Oasis may not be allowed to camp/park behind their booths to preserve the view shed along the creek, but will be allowed to camp for free nearby or in any other designated camping spots.*
4. Wi-Fi is available for merchant use to facilitate credit card transactions.
5. Vendor booth includes two (2) 4day YOJam passes, 4 day assistant passes can be purchased for \$75 (limit 4) and single day assistant passes for \$45 (limit 10).
6. Electricity is available for free, but we ask you use LED and low wattage voltage bulbs and bring at least one 100ft extension cord!
7. This event is **NOT** cancelled due to weather!
8. The Floyd Yoga Jam provides free drinking water and encourages use of this resource rather than bringing disposable plastic water bottles.
9. We want Vendors to have fun too! Your open hours are at your discretion, but we ask that you maintain core open hours of 11-6 daily. At other times, feel free to close your booth if you want to take a free yoga class or workshop...just hang a sign telling folks when you'll return!
10. Our Vendor Liaisons: Heidi for Jamland and Jennifer in Blissland will be available on setup Wednesday to help you get set-up and find what you need!
11. Floyd Yoga Jam's physical address is: 5430 Indian Valley Rd., Willis, VA 24380. Directions: From the stoplight in the Town of Floyd, VA travel 12 miles south on VA State Highway 221S, through the hamlet of Willis and turn right on Camp Five Rd. Follow to the end. Turn left onto Indian Valley Rd. Travel to the YOJam site on the right (just after the big white barn).
12. When you arrive, come to the **Box Office** for Vendor check-in and we will guide you to your spot. This includes **all** of your staff that will be working at your booth for the entire event.
13. Vendor agrees to obey all rules and instructions as directed by the Festival Director during the festival weekend. Any failure to strictly adhere to such rules or instructions may result in the immediate termination of this agreement and immediate forfeiture of any and all fees paid to Floyd Yoga Jam.
14. Vendor hereby acknowledges its liability, and agrees to compensate Floyd Yoga Jam, for any damage(s) caused by, including but not limited to, its representatives, agents, employees, volunteers, members, vehicles, equipment, materials and objects to the environs and infrastructure of city or private propriety which causes Floyd Yoga Jam to pay for repair, replacement, or other remuneration to Dancin' Dakinis or the property owners for such damage to the environs or infrastructure.
15. As a courtesy to other vendors and festival participants, any amplified sound or loud noise from Vendor's space is prohibited.
16. Floyd Yoga Jam reserves the right to prohibit, within any booth or on the festival grounds, the display, advertisement, or other promotion of any business, company, or organization which



may be in conflict with a current sponsor. Any questions concerning current sponsors should be directed to the Festival Director prior to the event.

- 17. Vendor shall not display, offer for view or sale any illegal or contraband items. The laws of the State of Virginia and local ordinances of Floyd County shall control. Vendors shall not display, offer for view or sale any items that are unlicensed and/or copies/interpretations of licensed or registered items at any site or operation of the 2019 festival.
- 18. Vendor understands and agrees that the Floyd Yoga Jam Festival is intended to be, and at all times shall be, a family friendly event.
- 19. Vendor shall not sublet its space without express written consent.
- 20. Vendor acknowledges and understands that it is solely responsible for the collection of any sales or use taxes and shall in no way hold Floyd Yoga Jam or its representatives responsible for any type of permits other than for the festival itself.
- 21. Vendor is solely responsible for the security for all its items at the festival location at all times.
- 22. Floyd Yoga Jam makes no representation or guarantees towards actual festival attendance.
- 23. Vendor understands that Floyd Yoga Jam has no control over weather, acts of God, acts of terrorism, or governmental intervention, or any other cause that may prevent, and or interrupt, the festival weekend, and participants shall not hold Floyd Yoga Jam harmless for any losses that could arise because of such events.
- 24. We reserve the right to place Vendors in booth locations at the complete discretion of Floyd Yoga Jam. Floyd Yoga Jam shall have sole and complete authority to place the participant in any location contained in the Market Place, irrespective of the participant's request.
- 25. Vendor upon vacating its space(s) shall ensure that such space shall be free of any and all trash and refuse with such being placed in the appropriate containers. Failure of the Vendor to clean their space may result in future refusal of Vendor application.
- 26. Vendor certifies that it maintains adequate liability insurance to cover any and all occurrences which may result in the damage or injury to any person or thing within the confines of the Vendor's space or as a result of the Vendor's actions at the festival.
