### FOOD BOOTH SPACE:

Vendors are invited to set up Wednesday, September 1st to avoid congestion. Gates open to the Public at 9am on Thursday, 9/2 and Food Vendors are encouraged to be up and ready for health dept. inspection, fire inspector, and public sales by noon Thursday am, 9/2, 2021. Vendors are asked to have their site cleared and cleaned by 5pm on Monday, September 6th. Food Booths include 4-(4) Day YOJam tickets, 20 amps electricity, free showers, camping and onsite parking on festival grounds.

All food and beverage vendors are provided a 10x20 booth space electricity supplied (20 amp only per vendor), please bring extra extension cords (min. 100 feet), potable water hose and splitters! Arrive Early for best site options and thank you for being flexible!

**\$500 Food Booth Fee Barter**—Thank You for providing performers and staff with your good food! Please accept YOJam Karma Kash for any 1 meal (\$10 face value) you offer at your booth \* for our hard-working staff and performers. Note: no change is owed to the customer. Please keep all karma cash tickets in the envelope provided which will be turned in at the closure of the festival. Vendors will be reimbursed at \$6.00 per coupon. Ice is available at cost plus tax from the Camp Store and will be deducted along with the \$500 booth fee after collection of Karma Kash at closure of the festival. Please allow 4-6 weeks for final reimbursement or invoice billing. \*Note, Smaller venues for drinks, will accept a drink worth \$5 face value, reimbursed at \$2 each, does not include foods from general store, chocolate bars or snack foods.
